Oregonians lean toward fairness

- 1987 Oregon's Sanctuary Law & Sanctuary Promise
- One Oregon coalition
- Extensive messaging research
- No on 105 victory
- Many legislative wins: Driver's Licenses, Paid Sick Days,
 Farmworker Overtime, Healthier Oregon and more.
- Oregon Worker Relief, including Equity Corps of Oregon

The Challenges Ahead

- Trump said he wants to deport two million immigrants. The scale of the mass deportations that President Trump and his surrogates have threatened would require the use of large detention camps.
- In his first term, he deported more than 200,000 people. President Trump and his surrogates have repeatedly said their plan includes the deportation of whole families, even though some family members may be citizens or have other documented status in the US.
- DHS/ICE does not have enough staff and resources to deport that many people. To accomplish the increases they have threatened, they would need the cooperation of local police and sheriffs and potentially the military, such as national guard, too.
- Trump will need more and new resources. Relatedly, they have also threatened to end fundamental current rights such as birthright citizenship, as well as long standing programs like DACA.



How Trump might use laws

- Insurrection Act
- Alien Enemies Act
- Laken Riley Act



Local Police & Sheriffs

- State law gives broad powers to sheriffs.
- Are there sufficient measures to prevent and address individual police and sheriff officers if they disregard Oregon values and laws - including our Sanctuary laws?
- We need more communication and support from Law Enforcement to ensure Oregon Sanctuary Law is implemented.



White Supremacist & Hate Groups

- There are white supremacist and hate groups in Oregon and Washington, including Proud Boys - some of whose leadership are in federal prison related to Jan 6 attack on the U.S. capitol.
- Some of these groups have relationships with police officers.
- Will these groups engage in increased harassment and violence of our communities or try to instigate counter protestors or engage in other actions to support President Trump's agenda?
